Please Review Section 3. Permit Required and Section 4. Permit Fee of Ordinance 2022-02

SECTION 3. PERMIT REQUIRED. No person shall place upon, cause to be placed upon or permit to remain on a Public Roadway or Private Property a Waste Dumpster or Portable Storage Container without first obtaining a permit therefore from the BOROUGH ZONING OFFICER OR DELEGATED APPOINTEE. **The duration of such permit shall be 10 Business Days from the date of the issued permit and continued validity of such permit shall be contingent upon full compliance with the regulations set forth below.** The Permit may be renewed up to two times for a Contingent maximum of no more than thirty (30) consecutive business days. Permittee will be required to resubmit application of permit for each extension. Extensions are not deemed automatic and must be approved by the BOROUGH ZONING OFFICER OR DELEGATED APPOINTEE. Extensions will not be renewed beyond thirty (30) consecutive days. Permits must be clearly placed on property to be visible from the public roadway.

SECTION 4. PERMIT FEE. The fee for a permit pursuant to this Ordinance is **Thirty- Five Dollars (\$35.00)**. No more than three (3) permits per landowner or resident shall be issued by the Borough within a twelve (12) month period for a dumpster or Portable Storage Container placed upon a public roadway.

Please review the following definitions of a “waste dumpster” and “portable storage containers”

Waste Dumpster - a unit designed for the deposit of waste materials at a property, house, dwelling, or building, located on a temporary basis on a public roadway abutting a site and the transportable to and from the site for the purposes of disposal of its contents by means of an approved carrying vehicle. A unit also designed to be placed off public roadway and on private property in a temporary manner.

Temporary Portable Storage Unit - a unit designed for the moving of personal goods, commonly located on a temporary basis on a public roadway abutting the site and transportable to and from the site for purposes of moving personal material by means of an approved carrying vehicle. A unit also designed to be placed on personal property located off of right of way of public roadway and on private property. Commonly referred to as PODS.
